



Illinois Health Benefits for Immigrants

Eligible: Non-qualified, non-citizen immigrant Illinois residents are eligible for the following Medicaid programs depending on age and income level:

- Birth through age 18: All Kids (Medicaid) if household income is at or less than 318% of the federal poverty level
- Pregnant adults at or below 210% of the federal poverty level are eligible for Moms & Babies, including for 1 year postpartum
- Adults age 42 64: (NOTE: program is paused since 7/1/23) at 138% of the federal poverty level,
- 65 and over, at or under 100% of the federal poverty level

Ineligible: Undocumented Illinois residents are ineligible for Medicaid programs, including Medicaid HCBS waiver programs if:

- Adults age 19 41 and not pregnant
- Students ages 19-21 still enrolled in school with IEPs (these students can find health care in a school-based health center, federally qualified health center or community health center (www.findahealthcenter.hrsa.gov) or can private pay for private insurance (not eligible for Marketplace plans)

Note: You can use your medical bills to reduce your countable income or assets. Your home and one car is not counted as an asset.

Covered Benefits through HBIA and HBIS:

Covered services include doctor and hospital care, lab tests, rehabilitative services such as physical and occupational therapy, home health, mental health and substance use disorder services, dental and vision services, and prescription drugs.

Long Term Care Services will not be covered. This includes nursing facility services and home or community-based waiver services as an alternative to facility services. HBIS - may cover prior health care up to 3 months before you apply.
